Further, the Board of Directors was empowered to vary the terms and conditions of his appointment, including his remuneration.

Based on the recommendation of the Nomination and Remuneration Committee, the Board at its meeting held on February 8, 2016, has appointed him as the Managing Director of the Company, subject to the approval of the members of the Company.

Further, considering his 22 Years of Experience in Finance & embroidery designing & textile sector and the pivotal role that he has been playing in the Management of the Company, the Board of Directors at their meeting held on August 13, 2016, have, based on the recommendation of the Nomination and Remuneration Committee, proposed to revise his salary to Rs. 30,000/- per month, with effect from October 1, 2016.


