

Travel curbs effective in nations with low number of cases: Study

TRAVEL RESTRICTIONS ARE effective in countries with low numbers of Covid-19 cases, or that have strong travel links with nations experiencing high rates of the viral infection, according to a study published in The Lancet Public Health journal. The study also suggests that travel restrictions may have been most effective during the early stages of the pandemic, and the measures are unlikely to be effective when the virus is already spreading rapidly within a country.

"We recognise that these measures carry a high economic and social cost, so it is important that governments use travel restrictions in a targeted way," said Professor Mark Jit from the London School of Hygiene and Tropical Medicine, who led the study.
